

STATEMENT OF FAITH

**To be signed annually by Board Members of the

We are an interdenominational movement,
united by our belief:

1. In the Divine Inspiration, Authority and
Sufficiency of the Christian Scriptures.
(2 Tim.3:15-16; 1 Pet.1:10-12; 2 Pet.1:20-21)

2. A) In one God, the creator of all.

B) In the Unity of the Godhead with
the distinction of Persons in that Unity
namely, The Father, The Son & The
Holy Spirit, to whom equal honour is
due.
(Gen.1:2+26; John 1:1-2; Heb.1:1-3+8;
1 John 5:7)

3. A) That the Son of God truly became
human, being begotten of the Holy
Spirit and born of the Virgin Mary.
(John 1:14; Rom.8:3; Matt.1:20-25; Gal.4:4)

B) That His Death was for our sake,
for the forgiveness of sins.
(Rom. 4:25; Eph. 1:5-10; 2 Cor. 5:21; 1 Tim
2:5-6; Heb.9:24 – 28; 1 John 2:2)

C) That He was raised from the dead.
(Matt. 28 5-7; 1 Cor. 15:20)

D) That He ascended to the right hand
of God, and is now the all sufficient
High Priest of His people.
(Acts 1:9; Heb.4:14-16)

E) That He will come again to dwell
amongst his people, and to fully
establish his eternal Kingdom.
(John 14:2; 1Thess.4:13-18; John 6:39-40;
Acts 1:10-11; 1 John 2:28; Titus 2:13)

4. That in consequence of the fall...

A) Humans are dislocated from their
rightful relationships with God,
creation, and each other, and...

B. Humans are unable to free
themselves from this state of Sin and
Death.
(Ps.53:2-3; Rom 5:12-14; Rom.8:5-7)

5. That the justification of the sinner
before God is by Faith alone.
(Rom.3:5-8, 10:9; 1 Pet.1:2; James 2:17)

6. In the need of the Holy Spirit's work in
regeneration and sanctification.
(John 3:5-8; 2 Cor. 3:18; 1 Pet. 1:2)

7. A) That at death humans do not cease
to exist.
(Luke 16:19-31; 2 Cor.5:6-8)

B) That the dead will be resurrected
either to eternal life with God, or to
final separation from him.
(1 Cor. 15:51-57; Rom 11:9-10; Acts 17:31;
Rev. 22:11-15)

8. That as followers of Christ, we are
called to make disciples, who will join
the church to participate in building
the coming Kingdom of God.
(Matt. 28:19-20; Mark 12:30-31; John 20:21;
Acts 1:8)
